DIRECTIONS FOR USE

For use on Established Grass and Turf Only. For best results, ensure even distribution across the application.

APPLICATION RATES

- Apply 32 ounces of Crabgrass Shield in a minimum of 1-1.5 gallons of water over 1000 sq. ft.
- Shake or agitate prior to mixing or applying
- Apply in early spring on established turf grass prior to weed germination
- Application times may vary due to weather conditions
- Up to 8 weeks of control on crabgrass and other grassy/broadleaf weeds*

FOR OPTIMAL RESULTS

Apply in spring/early summer to established turf grass before crabgrass emerges. When applying Crabgrass Shield allow product to dry before seeding. A second Crabgrass Shield application is recommended at the full rate 5 – 6 weeks after initial application. For best results, applications should be watered in to reach target weed bank.
